HYDRANTS

THERE ARE NO FIRE HYDRANTS OR PRIVATE PROTECTION DEVICES ON THE WATER SYSTEM. TWO INCH (2") FLUSH HYDRANTS INSTALLED ON THE SYSTEM ARE AVAILABLE TO FIRE COMPANY'S WITHIN THE AREA FOR GRAVITY USE TO FILL WATER TRUCK TANKS ONLY.

MEMBERSHIP

\$100.00, WHICH IS REFUNDABLE IF SERVICE IS EVER CANCELLED
THE METERS ARE READ THE THIRD FULL WEEK OF EVERY MONTH. THE BILLS GO OUT ON THE 1ST OF EVERY MONTH AND ARE DUE ON THE 17TH OF EVERY MONTH. IF BILLS ARE NOT PAID IN FULL BY THE 17TH OF EACH MONTH, A PENALTY OF 10% OF THE FIRST \$3.00/3% OF BALANCE WILL BE ACCESSED

DISCONNECT NOTICES

NOTICES WILL BE SENT OUT ON THE 18TH OF EACH MONTH FOR PAST DUE ACCOUNTS. ONCE A NOTICE IS SENT OUT OUR OFFICE CAN ONLY ACCEPT CASH, MONEY ORDER, CREDIT/DEBIT CARDS

RECONNECT FEE

IF THE NEED ARISES TO DISCONNECT ANY USERS SERVICE, THESE CHARGES WILL BE APPLIED TO RECONNECT THEIR SERVICE:

- DURING OFFICE HOURS - \$50.00
- AFTER OFFICE HOURS - \$100.00
- CUT LOCK CHARGE - \$75.00

\$50.00 RECONNECT FEE WILL BE CHARGED FOR ALL CURRENT MEMBERS WISHING TO HAVE SERVICE RESTORED AT ANOTHER RESIDENCE THAT HAS BEEN DISCONNECTED.

REQUEST TO RE-READ METERS

\$50.00 FEE WILL BE CHARGED FOR ALL CURRENT MEMBERS REQUESTING THEIR METERS RE-READ.

COLLECTION FEE

AT THE TIME OF DISCONNECT IF A USER PAYS THE WATER COMPANY FOR HIS BILL NOT TO DISCONNECT HIS SERVICE, BUT WE HAVE ALREADY MADE THE TRIP TO HIS RESIDENCE FOR DISCONNECT, THERE IS A \$20.00 COLLECTION FEE.

INSPECTION RECONNECT/DISCONNECT FEE

A \$40.00 FEE WILL BE CHARGED WHEN THIS REQUEST IS MADE FOR INSPECTION PURPOSES. THIS WILL BE FOR A TWENTY-FOUR (24) PERIOD.

TAP FEES (CONNECTION CHARGE)

EACH USER AT THE TIME HE/SHE IS CONNECTED WITH THE WATER WORKS SYSTEM SHALL PAY A FLAT CHARGE TO COVER THE COST OF:

EXCAVATION & TAPPING THE MAIN
FURNISHING & LAYING SERVICE PIPE
FURNISHING & INSTALLING YOKE, METER, CORPORATION STOP, AND METER BOX OR CROCK
5/8" BY 3/4" CONNECTION \$2,000.00, PLUS SHARE OF LINE EXTENSION IF APPLICABLE
ALL LARGER CONNECTIONS, COST,

****GRADING & SEEDING OF ALL AREAS AFFECTED BY METER INSTALLATIONS IS TO BE THE RESPONSIBILITY OF THE HOMEOWNER****

RETURNED CHECK FEE

A \$50.00 FEE WILL BE CHARGED FOR ALL CHECKS THAT ARE RETURNED TO OUR OFFICE. IF A CHECK IS RETURNED WE WILL ONLY ACCEPT CASH, MONEY ORDER, CREDIT/DEBIT CARDS

METER TEST FEE

A CHARGE OF \$50 WILL BE ASSESSED FOR A METER TEST AT THE REQUEST OF A MEMBER, IF THE RESULTS OF THAT TEST INDICATE THAT THE METER IS REGISTERING LESS THAN 98.0% OF ACTUAL USAGE.
